### ARTICLE 8: RETURN, REPLACEMENT, and WITHDRAWAL

In accordance with article L121-20 of the Code of consumption, the consumer has a period of 14 days from the date of delivery of the order, to return any item not agreeing to his expectations and ask for exchange (reshipping costs are the responsibility of the customer), or refund (except for actual shipping costs) without penalty. The returned products can only be accepted for products

in their original packaging that have not been used or tampered with and completely in good condition and standing (accessories, notice...), unused and together with a copy of the purchase invoice.

Any defective products, and on which a manufacturing defect will be shown, may be discussed. Any return of products must be done with our agreement, postage paid,

otherwise the claim will become obsolete, and the entire bill will be kept.

In case of an error on our part (recognized by us and accepted in writing via email), the customer or buyer must contact us via email, we will email you a "return form" to use for the return

of all purchased products. After returning the product and acceptance, we will exchange the product. If this procedure is not followed, we will not proceed to exchange or refund any product

Any manufacturing defects must be notified by email to Customer Service within 7 days after the receipt of the products, or invoice. After this period, no claim will be accepted.
